**Advertisement for Managing Director in CSPGCL**

Government of Chhattisgarh, Energy Department invites application from eligible candidates for selection and appointment/ deputation to the post of Managing Director on the Board of Chhattisgarh State Power Generation Company Limited. The selection for the post shall be done by a Selection Committee constituted by Government of Chhattisgarh in terms of provisions of the Article of Association of CSPGCL. The candidate should have a proven track record and have the initiative, capacity and drive to bring improvement in performance of the company.

The terms, conditions and eligibility for selection and appointment of Managing Director in CSPGCL are as below:-

- (1) **Educational Qualification:** Graduate degree with good academic record from recognized university/ institution. Degree in Mechanical/ Electrical / Civil Engineering will be preferred.
- (2) **Compulsory Experience:-**
  - (i) Minimum thirty years experience in a State or Central Power Utility, of which ten years experience should be in a power generation utility, as on 31<sup>st</sup> January, 2025 and
  - (ii) Minimum two years experience in the rank of Chief General Manager/Executive Director / Chief Engineer or higher position, of-
    - (a) Establishment of power generation project; or
    - (b) Operation / maintenance of power generation plant, of minimum 250 MW capacity.
- (3) **Desirable Experience:-**
  - (i) Experience of strategic planning and designing of power projects of 500MW and above will be desirable.
  - (ii) Experience of implementation of R&M schemes for old power generation units will be desirable.
- (4) **Remuneration / Pay Scale:-**
  - (i) The post of Managing Director is in the scale (O-6) of Rs. 116900-223800/- with all benefits including Dearness allowance and house rent allowances, medical and other facilities as are admissible to an Executive Director of CG State Power Generation Company Limited.
  - (ii) **For Appointment on Deputation :** Pay / Remuneration will be equal to
    - (a) His/her last pay drawn along with perks and facilities of the parent organization; or
    - (b) Pay / remuneration mentioned in clause (i) above, at the option of the candidate.
  - (iii) **For Retired Candidates :** Pay / remuneration will be equal to
    - (a) His/her last pay along with allowances and facilities received by the candidate in the parent organization **minus** pension, or
    - (b) Pay / remuneration mentioned in clause (i) above **minus** pension, at the option of candidate.

- (5) **Code of Conduct:-**  
The Managing Director Shall be required to maintain the highest standards of personal conduct and integrity and comply with all organizational policies. Any violation of these policies, Articles of association and/or CG Civil Services (conduct) Rules, 1965 may result in initiation of separation process.
- (6) **Exclusivity of engagement :-**  
Whilst employed with CSPGCL, The Managing Director shall not be permitted to undertake any other employment or engage in any external activities except those as may be directed by the appropriate authority of CSPGCL/Govt. of Chhattisgarh.
- (7) **Separation :-**  
The Managing Director may be removed or sent back or his engagement may be terminated before the expiry of the tenure by the appointing authority by giving one month's notice or one month's remuneration in lieu of it. The person appointed as Managing Director can also terminate the engagement by giving one month's prior notice or paying one month's remuneration in lieu of it.
- (8) **Jurisdiction :-**  
Any disputes arising out of the selection process as well as service matters shall be within the jurisdiction of courts situated at Bilaspur (C.G.) only.
- (9) **Who can apply :-**
- Chief General Manager/Chief Engineer/Executive Director of Chhattisgarh State Power Generation Company Limited having requisite essential experience.
  - Chief General Manager/Chief Engineer/Executive Director working in Central Sector Power Utilities having requisite essential experience may submit an advance application directly and application through proper channel be forwarded separately. If selected, such person will be appointed on deputation. His tenure will be governed by Deputation Rules of the sponsoring CPSU.
  - Retired person with requisite qualification & experience. Appointment of such person will be governed by Chhattisgarh Government (Contract Appointment) Rules 2012, as amended from time to time.
  - Age of applicant should be not more than 65 years as on 31.01.2025
  - Application in prescribed format be submitted.
- (10) **Terms and Conditions :-**
- Selection for the post of Managing Director shall be for the period of 3 years or attaining age of 65 years whichever is earlier.
  - Candidate and their kin should not involve in any other business with company or financially involved in any manner.
  - No pension will be provided after completion of such tenure as Managing Director.
  - The crucial date for determination of eligibility (qualification) of applicants for the post will be 31.01.2025.
