Code of Conduct:-(5)

The Managing Director Shall be required to maintain the highest standards of personal conduct and integrity and comply with all organizational policies. Exclusivity of engagement:-(6)

Whilst employed with CSPGCL, The Managing Director shall not be permitted to undertake any other employment or engage in any external activities except those as may be directed by the appropriate authority of CSPGCL/Govt. of Chhattisgarh.

Separation:-**(7)**

The Managing Director may be removed or sent back or his engagement may be terminated before the expiry of the tenure by the appointing authority by giving one month's notice or one month's remuneration in lieu of it. The person appointed as Managing Director can also terminate the engagement by giving one month's prior notice or paying one month's remuneration in lieu of it.
